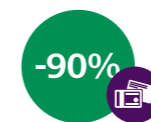
## Free travel

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Children until the child starts school, if accompanied by an adult	Any personal identification document
Citizens of Hungary or other EU, EEA Member States or Switzerland, aged 65+	Identity card or any other personal identification document
Foreign citizens aged 65+ who get retirement pension from the Hungarian Pension Fund	Certification of the Pension Fund and any other personal identification document
Foreign citizens with Hungarian nationality aged 65+ and their relatives aged 65+ on the basis of Act LXII/2001 (on Hungarians Living in Neighbouring Countries)	Personalised "Magyar igazolvány", and "Magyar hozzátartozói igazolvány"
Foreign citizens aged 65+ settled in Hungary on the basis of a special international agreement	Identity card or any other personal identification document
Refugees 65+, persons settled in Hungary and persons who have the freedom of movement and residence not based on citizenship.	Any personal identification document and any document certifying legal status
Blind customers (except on suburban railways outside of Budapest)	An official certificate issued by the Hungarian State Treasury and a document proving the identity, OR a valid photo ID issued by the Hungarian Federation for the Blind and Partially Sighted
Hearing-impaired customers (except on suburban railways outside of Budapest)	Valid photo ID issued by the Hungarian Association of the Deaf and Hard of Hearing
Children receiving higher family allowance and severely disabled persons according to Act XXVI/1998 (except on suburban railways outside of Budapest)	The Certificate of the Hungarian Treasury and personal ID
One accompanying person of the persons listed in the previous 3 points (blind, hearing-impaired and disabled customers, and persons receiving higher family allowance (except on suburban railways outside of Budapest)	Besides the certificate of the accompanied person, the accompanying person does not need any document, however the accompanying person is entitled to travel free of charge solely together with the accompanied person!
Hungarian disabled veterans and war widows	Certificate of disabled veterans and a personal ID
Accompanying person of disabled veteran	The certificate of disabled veterans states the necessity of an accompanying person based on medical expert opinion
Family member of a disabled veteran with at least 75 % disability (spouse, partner, children living in the same household) - (except on suburban railways outside of Budapest)	Personal ID and verifying document
People in possession of a resident permit waiting for refugee, asylum-seeker or protected status for transport services and occasions defined in the certificate	Residence permit for the applicant (foreign person) and a certificate issued by the Office of Immigration and Nationality
Refugees and asylum seekers for transport services and occasions defined in the certificate	On the basis of the certificate issued by the Office of Immigration and Nationality



## 90% discount on tickets

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Foreign citizens of Hungarian nationality between the ages of 6 and 65, four times a year, for return trips, based on Act LXII/2001	"Magyar igazolvány" or "Magyar hozzátartozói igazolvány"
A child or pupil from a special care institution and up to two attendants accompanying the child between their residence and the institution	Certificate on the special care of the child along with a certifying list of accompanying attendant(s)
Residents and non-residents in care of social institutions who are pupils, students or doctoral candidates travelling between the educational institution and their residence	Certificate of the institution
Up to 2 attendants of a resident or non-resident in care of a social institution travelling between the institution and their residence	
Visitors of residents of social institutions travelling between the institution and their residence	
The unemployed under the age of 18 taking part in vocational training supported by the Labour Market Fund or the European Union Fund travelling between their residence and the training institution	Certificate of the local job centre and personal photo ID
A group of at least 3 children in state care and 2 accompanying educators. If the group consists of more than 10 children, 2 attendants per each 10 group member	Certificate of the institution (list of travellers issued for the day of travel by the children's home)
Pensioners maximum 8 times a year if they use two reduced-price opportunities of the travel voucher at one time	Pensioner's travel voucher ("Ellátottak utazási utalványa"), personal photo ID
Pensioners twice a year, after the 50% discounts have been used up	
Unemployed customer travelling between the place of training supported by the Labour Market Fund or the European Union Fund and their residence	Certificate of the local job centre and personal ID
Blind customers, on suburban railways	Certificate issued by the Hungarian State Treasury and the personal identification card, or the valid photo ID issued by the Hungarian Federation for the Blind and Partially Sighted
Deaf and hearing-impaired customers, on suburban railways	Valid photo ID issued by the Hungarian Association of the Deaf and Hard of Hearing
Children receiving higher family allowance and severely disabled persons according to Act XXVI of 1998, on suburban railways	Certificate issued by the Hungarian State Treasury and the personal identification card
One attendant of the categories listed in the previous 3 points (blind, hearing impaired and disabled customers), on suburban railways	Besides the certificate of the accompanied person, the accompanying person does not need any document, however the accompanying person is entitled to travel free of charge solely together with the accompanied person!
Group of at least 10 customers as per Act LXII/2001 Article 8 Section 3 Point b, under the age of 18 with two attendants travelling with them, once a year for a return trip	On the basis of the pre-order by the group organiser – ticket collection only at BKK central ticket office by presenting "Magyar igazolvány" or "Magyar hozzátartozói igazolvány" IDs
Group of at least 10 EU, EEA Member State or Swiss citizens (and persons who have the freedom of movement and residence not based on citizenship) under the age of 18 along with two 18+ attendants travelling with them, once a year for a return trip	On the basis of the pre-order by the group organiser – ticket collection only at BKK central ticket office
Parent(s) and their at least 3 children travelling together <ul style="list-style-type: none"> <li>If the children are under the age of 18 or</li> <li>Under the age of 26 and attending regular courses of secondary or higher education with a valid student ID</li> <li>If any of the children – regardless of age – is entitled to a higher family allowance, with the certification of the social insurance office</li> </ul> If any family member is entitled to any other travel discount, they can use it without affecting the other family members' entitlement to this discount.	Photo ID and other certifying documents (e.g. student ID)



## 90% discount on passes

Schoolchildren (pupils) and secondary school students attending regular or evening courses for travel between the school/place of practical education and their residence	A valid permanent or temporary student ID and a certificate pursuant to Government Decree 362/2011 (XII. 30.)
Blind customers, on the suburban railways	Certificate issued by the Hungarian State Treasury and a personal identification card, or the valid photo ID issued by the Hungarian Federation for the Blind and Partially Sighted
Hearing-impaired customers, on the suburban railways	Valid photo ID issued by the Hungarian Association of the Deaf and Hard of Hearing
Children who get higher family allowance or severely disabled persons according to Act XXVI of 1998, on the suburban railways	Certificate issued by the Hungarian State Treasury and personal identification card



## 50% discount on tickets

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Students of regular and evening courses for any transport service	Valid student ID, permanent or temporary or a certificate pursuant to Government Decree 362/2011 (XII. 30.)
Correspondence course students of secondary schools up to the end of secondary education, students in higher education and PhD candidates for travel between the educational institution and their residence	
Pupils and students from EU, EEA Member States and Switzerland and persons who have freedom of movement and residence not based on citizenship attending regular or evening courses	Hungarian student ID, student ID issued by relevant state, international student ID (except for the type combined with a bankcard), in case of schoolchildren from abroad under the age of 16: passport or ID card. For confirming pupil, student or doctoral candidate status in an educational institution in Hungary, only the Hungarian student ID as per the Hungarian regulation is acceptable.
Students attending regular and evening courses in accordance with Government Decree 362/2001 (XII.30.)	Valid sticker applied in the booklet or the appendix of the "Magyar igazolvány" or "Magyar hozzátartozói igazolvány"
Pensioners; 16 times a year	Pensioner's travel voucher "Nyugdíjasok utazási utalványa" or "Ellátottak utazási utalványa"
Employees of Hungarian central budgetary institutions for return trips 12 times a year	Travel voucher- Annex 2 of Government Decree no. 85/2007. (IV.25.)
Members of clergy, employees of social organisations and foundations for return trips 12 times a year	
Family member of a disabled veteran with at least 75% disability can travel on regional buses free of charge and with a 50% travel discount on suburban railways. Only family members (spouse, partner, children) living in the same household are entitled to the travel benefit.	Photo ID and a certifying document
Two attendants accompanying a group of children under the age of 10 consisting of at least 6 members. If the group has more than 10 children, two more attendants per 10 group members	On the basis of the pre-order by the organiser
Maximum one attendant accompanying a group of 10 students attending regular courses	Valid student ID
