



# Regional transport discounts

## On buses and suburban railways outside the administrative boundaries of Budapest

### Free travel

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Until the child reaches the age of 14 (on the HÉV suburban railways: until the end of the school year in which the child reaches the age of 14). Children under 6 may only travel with an adult accompanying them.	Identity card, passport, student ID card including date of birth, „Magyar igazolvány”, „Magyar hozzátartozói igazolvány” or residence permit issued by a Hungarian authority
person over 65 (regardless of nationality or legal status)	Identity card, passport, driving licence in card format, „Magyar igazolvány”, „Magyar hozzátartozói igazolvány” or residence permit issued by a Hungarian authority
Pensioner holder of travel voucher issued by the Hungarian Pension Fund.	Travel voucher and identity card of the pensioner.
Blind persons	The official certificate issued by the Hungarian State Treasury together with a photo ID or a valid photo identity card of the Hungarian Association of the Blind and Visually Impaired
Hearing-impaired customers	Valid photo ID issued by the Hungarian Association of the Deaf and Hard of Hearing
A child receiving a higher family benefit and a person who is severely disabled under Act XXVI of 1998	An official certificate issued by the Hungarian State Treasury along with a photo ID
Persons listed in the previous 3 points (blind, deaf, severely disabled, recipients of higher family benefits) accompanied by 1 person	Besides the certificate of the accompanied person, the accompanying person does not need any document, however the accompanying person is entitled to travel free of charge solely together with the accompanied person!
Hungarian disabled veterans and war widows	Certificate of disabled veterans and a personal ID
Accompanying person of disabled veteran	The certificate of disabled veterans states the necessity of an accompanying person based on medical expert opinion THE DISCOUNT APPLIES ONLY FOR THE DURATION OF ACCOMPANIED TRAVEL.
Spouse/partner, child living in the same household with Hungarian war veteran with at least 75% disability	Personal ID and proof of entitlement
Refugee, sheltered person and asylum seeker the route and number of trips specified in the certificate	On the basis of the certificate issued by the Directorate-General for Aliens Policing along with a photo ID
A foreign national aged between 14 and 65 who is covered by the Act on Hungarians living in neighbouring countries; 12 times a year	„Magyar igazolvány” or „Magyar hozzátartozói igazolvány”
Pupil and up to 2 accompanying persons from an institution for children and pupils with special educational needs	Certificate on the special care of the child along with a certifying list of accompanying attendant(s)

Resident or non-resident in a social institution (who is a student or pupil)	Certificate of the institution
Up to 2 persons accompanying a resident or commuter cared for in a social institution	
Visitors of residents of social institutions travelling between the institution and their residence	
3 persons accompanying a group of at least 6 pre-school children. If there are more than 10 children travelling, an additional 3 accompanying persons per 10 children.	Passenger list issued and certified by the nursery for the day of the journey
Two attendants accompanying a group of children under the age of 10 consisting of at least 6 members. If the group has more than 10 children, two more attendants per 10 group members	Prior notification by the group organiser and identification, passport or student card required for group members
1 accompanying person when travelling with a group of at least 6 students aged 10 and over, studying full-time. For more than 10 students, 1 additional accompanying person per 10 students	Prior notification by the organiser of the group trip and a student ID card for group members is required
A group of at least 3 children fostered in a children's home or placed with a child protection foster carer and 2 accompanying educators. If the group consists of more than 10 children, 2 attendants per each 10 group member	Proof by the institution (pre-announced passenger list for the day of the trip issued by the children's centre or foster care network)
A group of at least 10 persons under the age of 18 as defined in Section 8 (3) (b) of the Act on Hungarians living in neighbouring countries, and two persons over the age of 18 accompanying them (1 time per year)	Prior notification by the group travel organiser and a „Magyar igazolvány”, „Magyar hozzátartozói igazolvány” is required for group members
Parent(s) and at least 3 children travelling with them, <ul style="list-style-type: none"> <li>• if the children are under 18 years of age, or</li> <li>• if the children are under 26 years of age and hold a valid student card for full-time students, and</li> <li>• if a child is entitled to a family allowance at the higher rate, irrespective of age, and this is certified by the disbursement agency.</li> </ul>	Photo ID along with proof of eligibility (e.g. student ID)

### 90% discount on passes

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Students in full-time or part-time education or training, or persons in vocational education or training	A valid Hungarian student ID* or a substitute certificate pursuant to Government Decree 362/2011 (XII. 30.)
* Holders of a Hungarian student ID can travel free of charge on the entire length of HÉV suburban railway lines and only within Budapest on suburban buses until the end of the school year in which they turn 14, and on suburban buses outside Budapest until they turn 14. Until then, they do not need to buy a pass.	
Pensioner holder of travel voucher issued by the Hungarian Pension Fund	Travel voucher ** and identity card of the pensioner (the number of the card must be provided when purchasing the pass)

\*\* Holders of a pensioner's travel voucher can travel free of charge on the entire length of suburban bus and HÉV suburban railway lines. Those who also travel on local lines in Budapest are recommended to buy a discounted Pest County or Hungary Pass.

### 50% ticket discount

ENTITLED CUSTOMERS	ACCEPTED DOCUMENT
Young people from age 14 to 25	Identity card, passport, student card with date of birth, driving licence in card format, „Magyar igazolvány”, „Magyar hozzátartozói igazolvány” or residence permit issued by a Hungarian authority
Employee of a Hungarian budgetary organisation or institution, religious legal person, non-governmental organisation	Travel voucher pursuant to the government decree on travel discounts
