## FREE TRAVEL

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Children until the end of the school year in which they reach the age of 14. Children under 6 must be accompanied by an adult.	No certificate is required until the age of 6; nursery school children need kindergarten certificate, while students require a Hungarian student ID
person over 65 (regardless of nationality or legal status)	Identity card, passport, driving licence in card format, „Magyar igazolvány”, „Magyar hozzátartozói igazolvány” or residence permit issued by a Hungarian authority
Blind persons	The official certificate issued by the Hungarian State Treasury together with a photo ID or a valid photo identity card of the Hungarian Association of the Blind and Visually Impaired
Hearing-impaired persons	Valid photo ID issued by the Hungarian Association of the Deaf and Hard of Hearing
Children receiving higher family allowance and severely disabled persons according to Act XXVI/1998	The Certificate of the Hungarian Treasury and personal ID
One accompanying person of the persons listed in the previous 3 points (blind, hearing-impaired and disabled customers, and persons receiving higher family allowance)	Based on the identity card of the person entitled, the accompanying person does not need any photo ID.  THE DISCOUNT APPLIES ONLY FOR THE DURATION OF ACCOMPANIED TRAVEL.
Hungarian disabled veterans and war widows	Certificate issued by a Hungarian authority together with personal photo ID
Accompanying person of a Hungarian disabled war veteran	The need for an escort recorded in the certificate issued by a Hungarian authority on the basis of medical expert opinion. DISCOUNT APPLIES ONLY FOR THE DURATION OF ACCOMPANIED TRAVEL
Spouse/partner, child living in the same household as a Hungarian disabled war veteran with at least 75% disability	Identity card, official certificate of residential address and military certificate issued by a Hungarian authority



## PENSIONER PASS

ELIGIBLE CUSTOMERS (up to the day before their 65th birthday)	ACCEPTED DOCUMENT
Pensioner holder of travel voucher issued by the Hungarian Pension Fund. Please note that the voucher can also be used as a basis for a discounted Pest County or Hungary Pass.	Travel voucher and identity card of the pensioner.
Customers of employable age receiving employment substituting benefit, allowance for disability or childcare, if not in employment	Certificate issued by the relevant government office together with a photo ID
Customers receiving disability allowance NOT IN possession of a pensioner travel certificate.	Certificate by the Hungarian State Treasury Pension Fund together with a photo ID



## DISCOUNTED PEST COUNTY AND HUNGARY PASSES

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Students in full-time or part-time education and students/adult learners undergoing vocational training	Valid Hungarian student ID or QR-coded certificate as per Government Decree 362/2011 (XII. 30). In the case of adult education in vocational training, a student ID and a certificate from the KRÉTA system.
Pensioner holder of travel voucher issued by the Hungarian Pension Fund	Travel voucher and identity card of the pensioner (the number of the card must be provided when purchasing the pass)



## PASS FOR JOB SEEKERS

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Person with a residential address in Budapest who has been registered as a job seeker by the competent district office.	Official unused document verifying job seeker status issued not later than 30 days previously for purchasing the pass, along with a photo ID and Hungarian address card.



## STUDENT PASS (Higher education)

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Students attending regular or evening courses	Valid student ID or certificate as per Government Decree 362/2011 (XII.30)
Students attending regular or evening courses based on Act LXII/2001 (on Hungarians Living in Neighbouring Countries)	A validating sticker in the booklet or the appendix of the „Magyar igazolvány” or „Magyar hozzátartozói igazolvány”
Students from EU, EEA Member States or Switzerland as well as family members with a residence card or permanent residence card issued in Hungary with the word “családtag” printed on it, attending regular daytime or evening courses in one of these states	Hungarian student ID, student ID issued by the relevant state in paper or card format, international student ID (except for the type combined with a bankcard).



## PUPIL PASS (Primary and secondary education)

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Pupils attending regular or evening courses in public education	Valid Hungarian student ID: both the ID type without a validation sticker and the type requiring a sticker for the school-year are accepted. Student IDs are valid without a sticker until 31 October following the end of the academic year in which the pupil reaches the age of 16.* Pupils without a student ID need a school-issued certificate according to Government Decree 362/2011 (XII. 30.)  With the above certificates, the student can travel free of charge within Budapest until the end of the school year in which s/ he reaches the age of 14. Student ID issued by the relevant state in paper or card format showing the name of a school outside Hungary; international student ID (except for the type combined with a bankcard)
Students from EU, EEA Member States or Switzerland as well as family members with a residence card or permanent residence card issued in Hungary with the word “családtag” printed on it, attending regular daytime or evening courses in one of these states	Students from EU, EEA Member States or Switzerland as well as family members with a residence card or permanent residence card issued in Hungary with the word “családtag” printed on it, attending regular daytime or evening courses in one of these states
Child without the above student IDs until s/he reaches the age of 14.	Personal identity card; passport; “Magyar igazolvány” or „Magyar hozzátartozói igazolvány”
Students attending regular or evening courses based on Act LXII/2001 (on Hungarians Living in Neighbouring Countries)	A validating sticker in the booklet or the appendix of the “Magyar igazolvány” or „Magyar hozzátartozói igazolvány”



## PASS FOR PARENTS WITH SMALL CHILDREN

ELIGIBLE CUSTOMERS	ACCEPTED DOCUMENT
Customers with a residential address in Budapest who receive child care allowance (GYES, GYET, GYED or CSED)	Official document verifying permanent or temporary Budapest residence and a photo ID along with an original certificate or resolution of the right to child care allowance issued within the last 6 months by the social insurance disbursement agency. In the case of GYES and GYET benefits, a valid, unrevoked official certificate for the childcare allowance dated more than 6 months ago may be accepted. In the case of GYED and CSED, a certificate is required that was issued by the disbursement agency and has an official stamp of any shape showing the mandatory data below in the following order: (1) “társadalombiztosítási kifizetőhely” text (2) company name and address (3) company registration number Without this stamp, the certificate cannot be accepted, and the BKK Pass ID for Parents will not be issued
